

## EV Charger Equipment Requirements Manufacturer Certification Form

EV charger manufacturers must use this form to self-certify that their equipment meets the necessary requirements to be installed as part of the Joint Utilities of New York's EV Make-Ready Program.<sup>1</sup> As of September 20, 2024, the communication standards requirements for chargers installed through the program were updated by the New York Public Service Commission.<sup>2</sup> This form attests to the most up-to-date requirements, which are as follows:

Effective October 18, 2024, Make-Ready projects that entered program agreements on or after December 16, 2023 to install DCFC chargers must use chargers that are:

- Hardware compliant with ISO 15118-3 and capable of enabling ISO 15118-2 or -20

Effective November 16, 2024, Make-Ready projects installing DCFC chargers must use chargers that are also:

- Capable of running software compliant with ISO 15118-2 or -20 once installed
- Hardware compliant with OCPP 2.0.1 or later

Effective October 18, 2024, Make-Ready projects that enter program agreements on or after June 1, 2025 to install Level 2 chargers must use chargers that are:

- Hardware compliant with ISO 15118-3 and capable of enabling ISO 15118-2 or -20
- Capable of running software compliant with ISO 15118-2 or -20
- Hardware capable of OCPP 2.0.1 or later

To have their equipment listed and eligible to be used in Make-Ready Program projects, manufacturers must fill out one form for each model of charger and email the pdf(s) of the completed form to [info@jointutilitiesofny.org](mailto:info@jointutilitiesofny.org) with the subject line: Equipment Requirements Certification: [Manufacturer name, Model name].

If any of the information submitted in this form changes, including the removal of certifications from any of the models submitted, it is the manufacturer's responsibility to resubmit this form within thirty (30) days of the date of such change. If the Joint Utilities determine that the equipment does not meet the capabilities as stated, participants in the Make-Ready Program will be ineligible for incentives.
